The City of Alexander City Building Department covers the City Limits for Inspections, however the Subdivision Regulations are enforced in the Police Jurisdiction. The Jurisdiction is 3 miles outside the City Limits. The primary functions of the Alexander City Building Department are as follows.

- Review of all residential and commercial plans of new construction and alterations to an existing structure for code compliance.
- Issue permits for Building, Electrical, Plumbing, Gas Fitting, HVAC/Mechanical, Certificates of Occupancy, Swimming Pools, Demolition, Signs, and House Moving.
- Field inspections to be called for on permits, to ensure code compliance: Footings, Temporary Electric, Plumbing under slab, rough-in, permanent electric, final with certificate of occupancy issued on new construction.
- Property Maintenance/Condemnation of structures
- Enforce local Ordinances/Codes
- Zoning type, special exceptions, variances, Zoning Ordinance

ORDINANCE NO. 2008-16

BE IT ORDAINED by the City Council of the City of Alexander City, Alabama, as follows:

SECTION 1. Duty of contractors and builders to obtain license and provide insurance.

It shall be the duty of every contractor or builder who shall make contracts for the erection, construction or repair of buildings for which a permit is required, and every contractor or builder making such contracts and subletting such contracts, or any part thereof, to pay a license tax as provided in the general license code and to register with the building official, giving his full name, residence and place of business, and, in case of removal from one place to another, to promptly report such change to the building official. It shall be the further duty of every person to conform to the building regulations, the regulations of this section, and other ordinances or laws applicable to such building. Contractors who purchase a building permit for any job in excess of \$10,000.00 or any plumbing, electrical, mechanical permit shall also file proof of a general liability insurance policy, including products and completed operations coverage, with minimum limits of \$100,000.00 for personal injury, death and property damage. The insurance company shall be one that is admitted to do business in Alabama. The certificate shall provide for at least ten days prior notice to the building official of the cancellation, revocation or nonrenewal of the policy.

SECTION 2. Severability; effect of article.

The provisions of this article are declared to be severable. If any portion of this article shall be held unconstitutional or otherwise invalid by a court of competent jurisdiction, such ruling shall

not affect the remaining portions of this article nor render the remaining portion of this article invalid.

SECTION 3. This ordinance shall become effective upon publication.
